## RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT

Exhibitor agrees that Exhibitor is solely responsible for any loss or damage to its property while the same is in transit to or from the SHOW, or while Exhibitor's property is at the SHOW. Exhibitor agrees that within the confines of the space(s) contracted for by the Exhibitor, neither West Fork Productions, Inc. nor their representatives shall be held liable or responsible for property loss, property damage, or any bodily injury to the Exhibitor or Exhibitor's employees, guests, visitors, or animal s while at the SHOW. Exhibitor is responsible for obtaining appropriate insurance coverage.

Exhibitor agrees that it is solely responsible for the health and safety of its animals while at the show and that Exhibitor is responsible for compliance with all laws, regulations, and local ordinances applicable to Exhibitor and/or its animals while at the SHOW.

Exhibitor shall be liable for any property damage or personal injury to any individual caused by Exhibitor or Exhibitor's employees, representatives, or animals. Exhibitor shall defend, indemnify and hold harmless West Fork Productions, Inc., its officers and employees from and against all claims, actions, suits, demands, proceedings costs, damages, and liabilities, arising out of, connected with, or resulting from any acts or omission of Exhibitor or any employee, representative, or animal of Exhibitor participating in the SHOW.

# **TEXAS PAW PARTY 2016**

## **NON-PROFIT RULES AND PROCEDURES**

**DEFINITION:** A “Non-Profit” Group is any group or company offering the adoption of homeless pets or animal related services for nonprofit.

### **AGREEMENT:**

- 1) Texas Paw Party will provide a space measuring 10' X 10' for the purpose of non-profits use during the event.
- 2) As applications are received, the non-profit will be listed on the Texas Paw Party website and other marketing material, so early receipt of applications is beneficial to both parties. Links to non-profit website will be provided at no additional charge.
- 3) All applications received prior to February 1 will be included on a map of the Festival.

### **CONSIDERATION:**

- 1) Two of more groups may share space for no additional charge, however, groups must remain in space allotted.
- 2) The booth fee is for the entire weekend. No space will be sold for individual days.
- 3) Texas Paw Party will not provide a canopy for any booth at the Festival.
- 4) Texas Paw Party will not provide tables, chairs or other booth supplies/equipment at the Festival
- 5) All tents must be fire retardant.
- 6) All animals must be crated, in an x-pen or on lead at all times. Each group is responsible for cleaning up after their animals.
- 7) In consideration of shop owners and attendees, no children under the age of 12 will be allowed to work as volunteers at this Festival. Children under this age must remain in the booth or must be accompanied by an adult when outside the booth.
- 8) All non-profit groups/shelters are eligible for the Texas Paw Party Rescue Group drawing.
- 9) Most communications will be via e-mail. Make sure we have a correct e-mail address and that our e-mails will not be blocked.

### **GENERAL INFORMATION:**

- 1) Festival Hours are Saturday, March 12, 2016 from 10 am to 5 pm and Sunday, March 13 from 11 am to 5 pm.
  1. The Festival is an outdoor event and will proceed rain or shine.
  2. There will be no early shutdown and no cars will be allowed in the festival grounds during festival hours.
  3. Payment must accompany your application packet which includes application, waiver agreement and, if 501.c.3., your Tax Exemption letter.
  4. Spaces are offered on a first-come first-served basis.
  5. In the event the Vendor desires to cancel, does not arrive for the event, or in case of rain/flood/natural disaster, **NO REFUND WILL BE GIVEN.**
