Exhibitor agrees that within the confines of the space(s) contracted for by the Exhibitor, neither West Fork Productions, Inc. nor their representatives shall be held liable or responsible for property loss, property damage, or any bodily injury to the Exhibitor or Exhibitor's employees, guests, visitors, or animal s while at the SHOW. Exhibitor is responsible for obtaining appropriate insurance coverage.

Exhibitor agrees that it is solely responsible for the health and safety of its animals while at the show and that Exhibitor is responsible for compliance with all laws, regulations, and local ordinances applicable to Exhibitor and/or its animals while at the SHOW.

Exhibitor shall be liable for any property damage or personal injury to any individual caused by Exhibitor or Exhibitor's employees, representatives, or animals. Exhibitor shall defend, indemnify and hold harmless West Fork Productions, Inc., its officers and employees from and against all claims, actions, suits, demands, proceedings costs, damages, and liabilities, arising out of, connected with, or resulting from any acts or omission of Exhibitor or any employee, representative, or animal of Exhibitor participating in the SHOW.

GENERAL INFORMATION FOR VENDORS

DEFINITIONS:

A "Vendor" is any individual or company offering one or more products or services "for profit".

A "Food Vendor" is any individual or company offering food products "for profit".

A "Commercial Vendor" is a company selling/marketing major products and services such as realtors, energy companies, vacation companies, spa companies "for profit" If you have a question about this category, call for clarification. Only a limited number of booths will be approved for this category.

RULES AND PROCEDURES:

- 1. Festival Hours are Saturday, March 12, 2016 from 10 am to 5 pm and Sunday, March 13 from 11 am to 5 pm.
- 2. The Festival is an outdoor event and will proceed rain or shine.
- 3. There will be no early shutdown and no cars will be allowed in the festival grounds during festival hours.
- 4. Payment must accompany your application packet which includes application, signed waiver agreement and photos of setup and products.
- 5. Spaces are offered on a first-come first-served basis.
- 6. Vendor IS required to provide his/her own set up, including tents, tables, chairs, extension cords, etc. Sufficient tent tie downs and weights are required. TENTS MUST BE FIRE RETARDANT.
- 7. Vendor is responsible for cleaning his/her own area, disposing of trash in the appropriate areas and returning the festival area to its original condition.
- 8. Each space allotment is 10' x 10".
- 9. This is a juried show. You must send photos of your set up and products for Committee review. If you are sharing a booth with another vendor, their items must also be approved. Diversity of products for sale at the Festival is very important to Festival organizers and is part of the criteria for acceptance in the Festival. Payment will be returned to you if your application is not approved.
- 10. As applications are approved, vendors will be listed on the Texas Paw Party website and other marketing material. Links to vendor website will be provided at no additional charge.
- 11. You will be notified by email of your acceptance. Most communications will be via e-mail. Make sure we have a correct e-mail address and that our e-mails will not be blocked.
- 12. Your Sales Tax Certificate must be displayed in booth during Festival hours.
- 13. Food vendors require a permit from the Harris County Health Department. Go to www.hcphes.org for more information and application. Cost is \$80.00 prior to the event. The cost doubles after the Festival opens.
- 14. <u>ALL FEES MUST BE PAID AND IN OUR OFFICE BY March 1, 2016. LATE PAYMENTS MUST BE IN CASH AND LATE FEES WILL BE APPLIED.</u>
- 15. In the event the Vendor desires to cancel, does not arrive for the event, or in case of rain/flood/natural disaster, **NO REFUND WILL BE GIVEN**.
